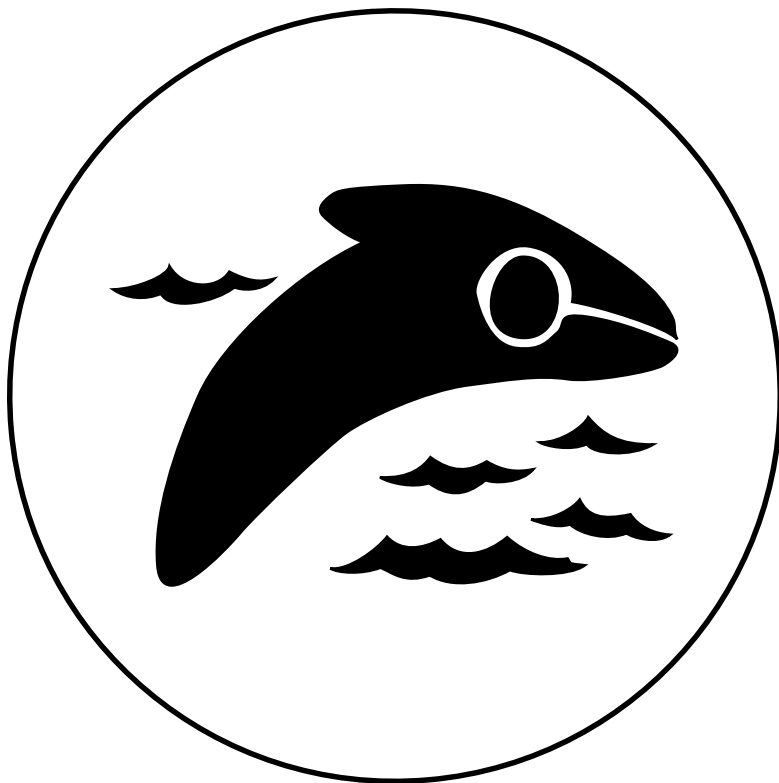

The Publications Committee invites the submittal of original contributions dealing with the history and prehistory of the area. Although PCAS is especially interested in reports which shed further light on the early inhabitants of Orange County, it is always interested in reports on the wider Pacific Coast region.

Subscription to the *Pacific Coast Archaeological Society Quarterly* costs \$37 for calendar year 2008. The PCAS also publishes a monthly newsletter, which costs \$18 for calendar year 2008. About the Authors

Guillermo Avila Serrano is an oceanographer and research professor in the Faculty of Marine Sciences of the Universidad Autónoma de Baja California (UABC). He holds a masters in science degree in coastal oceanography from UABC and is currently pursuing his doctorate in coastal oceanography from the same university. He is a member of the Peninsular Geological Society and the Association of Oceanographers of Mexico. His research interest concerns taphonomic processes, paleoecology, and quantitative analysis of mollusks.

Robert Brinkmann is Professor of Geography at the University of South Florida. He serves as Chair of the Department. He holds B.S. and M.S. degrees in Geology and a Ph.D. in Geography. Dr. Brinkmann has conducted geoarchaeological work in many areas of the US and in the Middle East. In addition to his geoarchaeological research, he studies sediment pollution and the characteristics of street sediment.

Loren G. Davis is an assistant professor in the Department of Anthropology at Oregon State University. He received a B.Sc. in Anthropology and M.A.I.S. in Anthropology, Geography, Soil Science from Oregon State University, and a Ph.D. in Anthropology from the University of Alberta, Edmonton, Canada. His research largely includes the early record (pre-8,000 BP) of hunter-gatherers in western North America. Since 1996, he has led multiple archaeological and geoarchaeological investigations in Baja California in search of late Pleistocene-age occupations and to study the prehistoric record of human-environmental interaction.

Karl W. Flessa has been a professor in the Department of Geosciences at the University of Arizona in Tucson since 1977. He holds a B.A. in geology from Lafayette College and a Ph.D. in geological sciences from Brown University. He has published numerous articles on paleontology, particularly concerned with evolution and the fossil record. He has worked several years in the Colorado delta on taphonomic processes in mollusks, using this analysis to evaluate changes in the delta's ecology through isotopic methods.

Lynne Goldstein has a B.A. in Anthropology from Beloit College, and an M.A. and Ph.D. in Anthropology from Northwestern University. Since 1996, she has been Professor of Anthropology at Michigan State University, where she served as Chairperson from 1996 to 2006. She was previously at the University of Wisconsin-Milwaukee for 21 years. She has conducted fieldwork in various places, but particularly in Illinois, Wisconsin, and California. Her research has focused on prehistoric Late Woodland and Mississippian societies in the Midwest (especially the Aztalan site), historic Euro-American cemeteries, and the historic Russian Orthodox cemetery at Fort Ross.

Dave Iversen earned a B.A. in Anthropology from the University of Washington and is currently completing an M.A. in Anthropology at Washington State University. With Mark S. Becker he wrote “Prehistoric Coastal Adaptations in Southern California: A Perspective from the Lithic Artifacts” for Modeling Mid-Latitude Littoral Hunter-Gatherers: Inter-Disciplinary Investigations at San Elijo Lagoon, Southern California, an NSF report edited by Brian F. Byrd. He is a Project Archaeologist with ASM Affiliates in Carlsbad, California.

Don Laylander received a B.A. in History from UCLA and an M.A. in anthropology from San Diego State University. He has made several contributions to the *PCAS Quarterly*, including “The Last Days of Lake Cahuilla: The Elmore Site” (1997). He has also written for the *Journal of California and Great Basin Anthropology*, *Estudios Fronterizos*, *Proceedings of the Society for California Archaeology*, *Southern California Quarterly*, and other publications. With Jerry D. Moore, he recently edited *The Prehistory of Baja California: Advances in the Archaeology of the Forgotten Peninsula* (2006). He is a Senior Archaeologist with ASM Affiliates in Carlsbad, California.

Miguel Agustín Téllez Duarte is an oceanographer and research professor in the Faculty of Marine Sciences of the Universidad Autónoma de Baja California (UABC). He holds a masters in science degree in oceanography with marine ecology orientation and a doctorate in earth sciences with a geology major from the Centro de Investigación Científica y de Educación Superior de Ensenada (CICESE). He is a member of the Seminar on the History of Baja California, Inc., the Mexican Paleontological Society, and the Peninsular Geological Society, among others. He has worked on the paleoecology of mollusks and taphonomic processes in paleontological and archaeological deposits.
