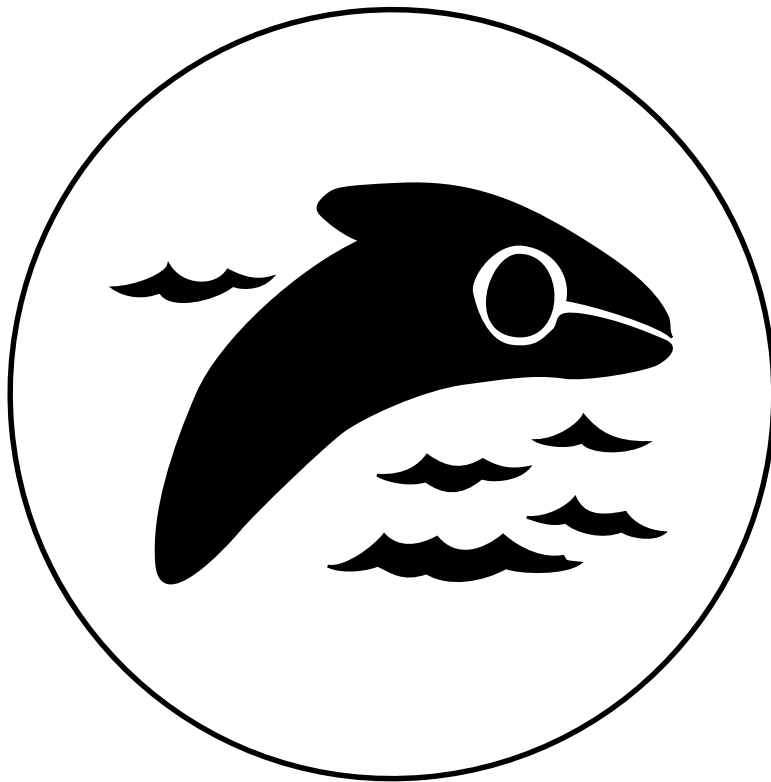

The Publications Committee invites the submittal of original contributions dealing with the history and prehistory of the area. Although PCAS is especially interested in reports which shed further light on the early inhabitants of Orange County, it is always interested in reports on the wider Pacific Coast region.

About the Authors

Jon M. Erlandson received his Ph.D. in Anthropology from the University of California, Santa Barbara in 1988. A Professor of Anthropology and Knight Professor of Liberal Arts and Sciences at the University of Oregon, he has spent 25 years studying the archaeology of coastal California and the Pacific Coast of North America. Erlandson has published over 100 scholarly articles, books, or edited volumes on these and other topics.

Douglas J. Kennett received his Ph.D. in Anthropology from the University of California Santa Barbara in 1998. An Assistant Professor at the University of Oregon, Kennett has published extensively on behavioral ecology and the archaeology of California's Northern Channel Islands. His current research projects involve archaeological fieldwork on Rapa, French Polynesia, and the Pacific Coast of southern Mexico.

Melissa R. Reid received her B.S. in Anthropology from the University of Oregon. Her research interests include coastal archaeology, shell midden analysis, bioarchaeology, human osteology, and forensic anthropology. She has field experience on the Channel Islands, the California Coast, and Iceland. She is currently laboratory assistant in the Coastal Archaeology and Human Ecology Laboratory at the University of Oregon.

Torben C. Rick is a Ph.D. candidate in Anthropology at the University of Oregon. With research interests in coastal and maritime societies, social and economic complexity, and zooarchaeology, Rick has worked on numerous archaeological projects on the Channel Islands, southern California Coast, and Pacific Northwest. His dissertation research focuses on the Late Holocene archaeology of San Miguel and Santa Rosa islands.

Craig E. Skinner completed B.S. and Ed.M. degrees at Oregon State University and M.S. degrees in Interdisciplinary Studies and Anthropology at the University of Oregon.
