About the Authors

Matthew A. Buxt, Ph.D., received his B.A. from UC Berkeley (1976) and his M.A. (1979) and Ph.D. (1993) from the University of California, Los Angeles. His research interests include Mesoamerica and the archaeology of Baja California Sur. Buxt has conducted fieldwork in Belize, Guatemala, Mexico, and southern California. He is currently a lecturer in the CSU Northridge Department of Anthropology.

Sara L. Gonzalez is a doctoral candidate in the Department of Anthropology at UC Berkeley. She is completing her dissertation on the archaeology of colonialism, community archaeology, and public outreach at Fort Ross State Historic Park.

Kent G. Lightfoot, Ph.D., has taught in the Anthropology Department at UC Berkeley since 1987. He received his undergraduate and graduate degrees in anthropology from Stanford University and Arizona State University and has been involved in archaeological research for over 25 years in the American Southwest, New England, and California.

Fermín Reygadas Dahl, M.S., has a Bachelor's Degree in archaeology from the National School of Anthropology and History in Mexico City and an M.S. in geosciences from Mississippi State University, Starkville (2006). He is currently Professor and Researcher in the Social Sciences Division at the Autonomous University of Baja California Sur (UABCS), La Paz. Reygadas Dahl is widely recognized as an authority on Baja California, with over 30 years experience in the field. He has written extensively on the Cape Region's Pericú Indians, focusing on their settlement and subsistence patterns. In recent years, Reygadas Dahl has studied the technology and subsistence-economics of ancient Californians through the medium of experimental archaeology, data from which he has presented in lectures, talks, and displays at museums in Cabo San Lucas, La Paz, Mexico City, and Tijuana. Reygadas Dahl is co-principal investigator of the UABCS-CSUN Piedra Pintada Archaeological Research Project, and he has been responsible for developing curriculum for a UABCS-CSU Northridge distance-learning program, blending classroom and field experiences.

Michael Sampson, M.A., is an archaeologist with California State Parks in San Diego, and he has been involved in the field of Archaeology since Richard Nixon's presidency. He worked on his first historical archaeology project in 1976. He has a B.A. degree in anthropology from California State University, Northridge, and an M.A. degree in anthropology from Washington State University. His research interests include California prehistory, stone tool technology and tool function analysis, the archaeology of the California deserts, the Contact period in California, mining in the western U.S., California red wines, and other subjects. Michael is a past president of the Society for California Archaeology, and he provides peer review for local journals.

Tsim D. Schneider, M.A., is a doctoral candidate at the University of California, Berkeley. He earned a B.A. in anthropology in 2001 and an M.A. in anthropology in 2003 from the University of Texas at Austin. His dissertation research examines the long term function and meaning of shell mounds, complex hunter-gatherers, and colonial encounters in the San Francisco Bay area.

Guillermo Velázquez Ramírez earned his Bachelor's Degree in archaeology from the National School of Anthropology and History in Mexico City (1982). He is currently Professor of Anthropology in the Division of Social Sciences at the University of Quintana Roo, Chetumal. Velázquez Ramírez has 30 years of archaeological experience in Mexico, ranging from the survey and mapping of hunter-gatherer sites in Baja California to the excavation of Chacabakan and other ancient Maya cities on the Yucatan Peninsula.
