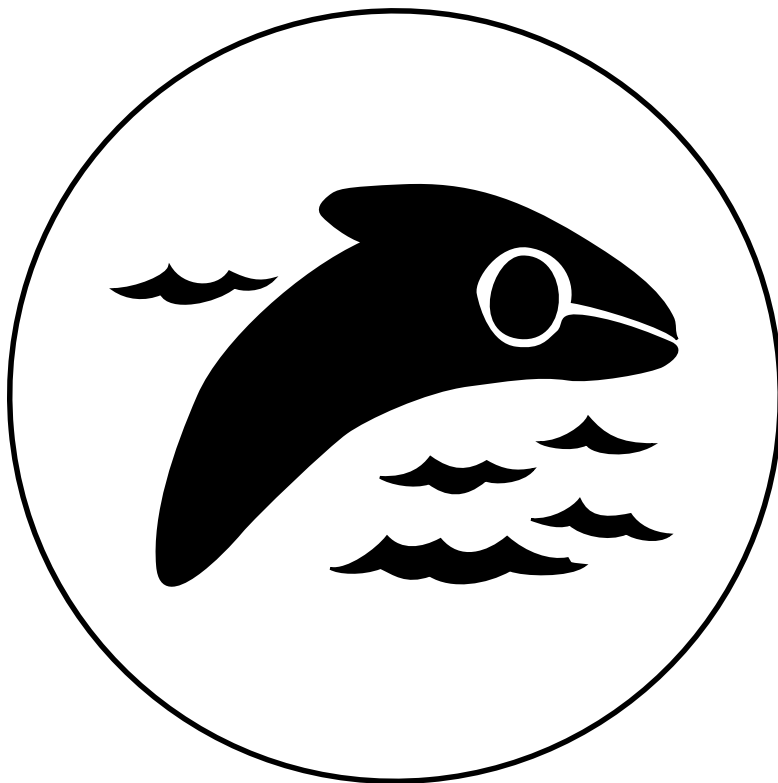

The Publications Committee invites the submittal of original contributions dealing with the history and prehistory of the area. Although PCAS is especially interested in reports which shed further light on the early inhabitants of Orange County, it is always interested in reports on the wider Pacific Coast region.

Subscription to the *Pacific Coast Archaeological Society Quarterly* costs \$37 for calendar year 2008. The PCAS also publishes a monthly newsletter, which costs \$18 for calendar year 2008. About the Authors

Todd J. Braje earned his Ph.D. from the University of Oregon in 2007 and is now a Visiting Assistant Professor in the Department of Anthropology at Humboldt State University. His primary research interests focus on historical ecology, hunter-gatherer-fisher studies, and coastal adaptations. Braje has worked on archaeological projects in Oregon, Florida, Belize, and California. His dissertation and post-doctoral research explores trans-Holocene settlement, subsistence, and technological change and human impacts on marine ecosystems on San Miguel Island.

Jon M. Erlandson is a Professor of Anthropology, Knight Professor of Arts and Sciences, and Executive Director of the Museum of Natural and Cultural History at the University of Oregon. He earned his Ph.D. in anthropology from the University of California, Santa Barbara in 1988 and has spent 30 years studying the archaeology of coastal California and the Pacific Coast of North America. Erlandson has published 16 books and over 200 scholarly articles on these and other topics.

Leslie A. Reeder is a doctoral student at Southern Methodist University. She has research interests in paleoethnobotany, paleoecology, and early coastal hunter-gatherers. Her previous research spans most of North American prehistory, and includes work on the northern California Coast, the Channel Islands of southern California, and the Rocky Mountains region.

Torben C. Rick received his Ph.D. in anthropology from the University of Oregon in 2004. An Assistant Professor of Anthropology at Southern Methodist University, he has published widely on the archaeology and historical ecology of maritime hunter-gatherers. With research interests in coastal and maritime societies, social and economic complexity, and zooarchaeology, Rick has over 13 years of archaeological experience on the Channel Islands, southern California Coast, and Pacific Northwest.

Kelly Shaw earned a B.A. in anthropology and history in 2006 from the University of Oregon, where he was a McNair Scholar. His research interests include archaeological and social method and theory, material culture studies, and the history of technology. Currently a graduate student at the University of Oregon, he has been involved in archaeological research in the Northwest Coast, Great Basin, Columbia Plateau, and California culture areas.

Christopher B. Wolff received an M.A. in anthropology from Memorial University of Newfoundland in 2003 and is now a Ph.D. candidate in anthropology at Southern Methodist University. He has conducted research along the northeastern Subarctic Coast of North America over the last six years where he examined the dynamics of social complexity, spatial organization, and coastal adaptations of various Archaic and Paleoeskimo groups. In recent years, he has extended his research interests to include the Channel Islands of southern California.
